Based on the on the recommendations of the University Inspection Committee which visited the college on 28-06-2018 to verify the infrastructural facilities made available by the college and to verify the extent of fulfillment of the conditions stipulated in the affiliation orders 2017-18, the University has accorded approval for grant extension of provisional affiliation to R.G. Kedia College of Commerce, Esamiabazar, Hyderabad to offer M.Sc (Mathematics) Course with intake of (40) for the academic year 2018-19, subject to fulfillment of the following conditions and general rules of affiliation:

CONDITIONS:

- 1. To appoint Director and two teachers through duly constituted Selection Committee as per OU norms for the academic year 2018-19.
- 2. To purchase books worth Rs.20,000/- for the year 2018-19.
- 3. To subscribe for two National and four International Journals for the year 2018-19.
- 4. To upload faculty information on the University web site.
- 5. To provide parking facility.
- 6. To submit Sanitary certificate for the year 2018-19.
- 7. To submit Fire Safety Certificate from the competent authority.
- 8. Teaching diaries and Students attendance registers are to be maintained as per norms;
- 9. Governing Body meetings are to be conducted thrice in a year by associating University representative on the Governing Body;
- 10. All the transactions including payment of salaries to the staff should be made through bank.
- 11. The faculty to be deputed for refresher courses/orientation programmes/Faculty Development programmes conducted by OU and other Institutions.

You are, therefore, directed to submit the Compliance Report on the fulfillment of the above deficiencies in the following format along with the documentary evidence to reach this office within one month from the date of issue of these orders, through the University representative on the Governing Body of the College.
