- 3. To subscribe for two National and four International Journals for the year 2021-2022.
- 4. To upload faculty information on the University web site.
- 5. To provide parking facility.
- 6. To submit Sanitary certificate for the year 2021-2022.
- 7. To submit Fire Safety Certificate from the competent authority.
- 8. Teaching diaries and Students attendance registers are to be maintained as per norms;
- 9. Governing Body meetings are to be conducted thrice in a year by associating University representative on the Governing Body;
- 10. All the transactions including payment of salaries to the staff should be made through
