## **CONDITIONS**:

- To appoint required teachers through duly constituted Selection Committee as per OU norms for the academic year 2022-2023.
- 2. To purchase books worth Rs.10,000/- for the year 2022-2023.
- 3. To subscribe for two National and four International Journals for the year 2022-2023.
- 4. To upload faculty information on the University web site.
- 5. To provide parking facility.
- 6. To submit Sanitary certificate for the year 2022-2023.
- 7. To submit Fire Safety Certificate from the competent authority.
- 8. Teaching diaries and Students attendance registers are to be maintained as per norms;
- 9. Governing Body meetings are to be conducted thrice in a year by associating University representative on the Governing Body;
- 10. All the transactions including payment of salaries to the staff should be made through bank.
- 11. The faculty to be deputed for refresher courses/orientation programmes/Faculty Development programmes conducted by OU and other Institutions.
