Kedia College of Commerce, Esamiabazar, Hyderabad** to offer **M.Sc (Mathematics) Course** with intake of **(40)** for the academic year **2022-2023**, subject to fulfillment of the following conditions and general rules of affiliation :


CONDITIONS :

1. To appoint required teachers through duly constituted Selection Committee as per OU norms for the academic year 2022-2023.
2. To purchase books worth Rs.10,000/- for the year 2022-2023.
3. To subscribe for two National and four International Journals for the year 2022-2023.
4. To upload faculty information on the University web site.
5. To provide parking facility.
6. To submit Sanitary certificate for the year 2022-2023.
7. To submit Fire Safety Certificate from the competent authority.
8. Teaching diaries and Students attendance registers are to be maintained as per norms;
9. Governing Body meetings are to be conducted thrice in a year by associating University representative on the Governing Body;
10. All the transactions including payment of salaries to the staff should be made through bank.
11. The faculty to be deputed for refresher courses/orientation programmes/Faculty Development programmes conducted by OU and other Institutions.
